



# CINCINNATI FLYING PIG MARATHON TERMS & CONDITIONS

## CANCELLATION POLICY

Entry fees are non-refundable. This means that once we have received your entry, you will not receive a refund if you cannot participate, or if the event is cancelled because of weather, natural disaster or other unforeseen circumstances. ## **PARTICIPATION**

Participating in a road race is a potentially hazardous activity. Runners should be medically able and properly trained to participate in the Cincinnati Flying Pig Marathon. The runner understands the risks associated with running this event, including, but not limited to, weather traffic, course conditions and surfaces, falls and contact with other runners, volunteers, or spectators. Wheelchair entrants must wear helmets at all times. Due to logistical and safety issues, the Marathon is not currently able to accommodate hand crank chairs.

## MEDICAL SUPPORT

Medical support for this event will be provided by volunteer personnel who may be called upon to provide assistance, including first aid, during or after the event. Medical volunteers will assist participants as necessary or appropriate. By entering a Marathon event and participating, the entrant agrees to treatment by medical personnel, and also agrees to accept medical decisions about the entrant's fitness to participate or continue the race.

## **RULES AND REGULATIONS**

Runners agree to obey and accept the rules of this race and any related events and abide by the decision of any race official concerning the runner's ability to safely complete the run. The following items are not permitted in the Cincinnati Flying Pig Marathon: pets (except for Flying Fun Run), skateboards, bicycles, roller blades, baby joggers (exception: baby joggers are allowed in the Saturday races only), or any other types of vehicles (other than official Marathon vehicles). These regulations are for the participant's safety and the safety of the other participants in the race. The Cincinnati Flying Pig Marathon reserves the right to disqualify and remove anyone from the course who has any of the above items.

## **COURSE**

The course will close on a continuous pace of 16:00 minutes per mile. Anyone who cannot maintain the 16:00 minute per mile pace must move to the sidewalk as the course closes to allow regular traffic through. Runner services cannot be guaranteed for participants beyond the 16:00 minute per mile pace.

## DRUG TESTING

Athletes who participate in this competition may be subject to formal drug testing in accordance with USA Track & Field rules and IAAF rule 144. Information regarding drugs and drug testing may be obtained by calling the USOC Hot Line at 1-800-223-0393.

## **HEADPHONES**

The Cincinnati Flying Pig Marathon requests that participants refrain from the use of headphones of any type on the event courses. The request is for not only the safety of the participant, but also spectators and volunteers. The Flying Pig Marathon has made it a priority to provide entertainment zones all along the course to replace the need for participants to carry their own music. The marathon is also known for its crowd support cheering and motivating the participants. The Flying Pig Marathon continues to ask for the participants' cooperation in this matter.

## LIABILITY WAIVER AND RACE AGREEMENT

(Team LADD), all sponsors, officials, volunteers, Marathon staff, directors and officers, together with their subsidiaries, successors, heirs, contractors, subcontractors, directors, officers, agents, attorneys, and representatives from all claims of liabilities of any kind and character whatsoever, including, without limitation, for any claim of negligence and all liability for injuries to person or property suffered by me, arising from my participation in the Marathon or any of its allied, post and pre-race activities, or accompanying events. By execution of this waiver, I assume all risks associated with my participation in this event, including, but not limited to falls and the effects of volunteers, staff, other participants, exposure to infectious or other diseases, weather, traffic, and road conditions, defects and imperfections, and acknowledge and accept that all such risks are known and appreciated by me. I understand that participants in the Marathon are subject to drug testing as described in the Terms and Conditions (stated above and at www.flvingpigmarathon.com). I will not enter and run unless I am medically able and properly trained to do so. I consent and grant full permission to the use of my image or likeness in photos, video and audio recording, and film, of my participation in all Marathon events.
