



SPLIT-THE-POT 50/50 RAFFLE

OFFICIAL RULES

PURCHASE OF A RAFFLE TICKET IS NOT A TAX-DEDUCTIBLE CONTRIBUTION.

Living Arrangements for the Developmentally Disabled, Inc. (LADD) hosts the Split-the-Pot 50/50 Raffle (the "Raffle") for fundraising purposes. By purchasing a ticket for the Raffle, each eligible participant (a "Participant") represents that s/he meets all of the below-stated eligibility requirements and agrees to be bound by these Official Rules, all applicable laws, ordinances and regulations, and by the decisions of LADD, a 501(c)3 charitable organization, or its authorized representatives.

RAFFLE PERIOD: Raffle tickets will be made available for purchase beginning June 5, 2025, 10 a.m. ET through July 31, 2025, 1 p.m. ET. LADD reserves the right to extend the Raffle Period at its sole discretion.

ELIGIBILITY: The Raffle is open to legal U.S. residents who are 18 years of age or older at time of entry. Void where prohibited. LADD ("Sponsor"), its parent companies, subsidiaries, affiliates, advertising agencies, prize suppliers, including any vendors providing services in connection with this Raffle (collectively, the "Sponsor Affiliates"); and employees, agents, directors, officers (including members of their immediate family – i.e., spouse, mother, father, in-laws, grandmother, grandfather, brother, sister, children and grandchildren – or same household) of Sponsor or any Sponsor Affiliates are not eligible to participate.

ENTRY: During the Promotion Period, you may enter the Raffle by purchasing a raffle ticket ("Ticket") for one hundred dollars (\$100) from Sponsor by completing a registration form and tendering payment. For each Ticket purchased, the person for whose name and information is listed on the registration form will receive one (1) entry into the Grand Prize Promotion (explained below).

The purchase of a raffle ticket is not a tax-deductible contribution. Payment is accepted by check, money order or credit card (American Express, Discover, Visa or MasterCard). Checks or money orders should be made payable to "LADD", attached to a completed registration form and mailed to Split-the-Pot, LADD, 3603 Victory Parkway, Cincinnati, Ohio 45229. Credit card payment is accepted by calling our toll-free number at 1-877-861-5233, or on LADD's secure website (laddinc.org) or by providing credit card information on a completed registration form. If an entrant's check or credit card is dishonored, Sponsor will attempt to notify the entrant by mail, e-mail or phone at Sponsor's discretion; and, if unsuccessful, the submitted entry may be declared invalid and the ticket may be awarded to the next chronological entrant.

No mechanically reproduced entries of any kind permitted. Illegible and incomplete entries are void. Sponsor is not responsible for lost, late, mutilated, postage due, misdirected entries or entries not received regardless of cause.

BONUS DRAWING PROMOTION: Bi-weekly bonus drawings (the "Weekly Drawing Promotion") consist of fourteen (14) separate drawings (taking place on pre-determined dates) during the Promotion Period, starting with the drawing on Thursday, June 12, 2025, and ending on July 29, 2025.

Potential winners will be selected by random drawing on or about the relevant Drawing Date from all Tickets purchased and registered during the Promotion Period up to the date of the Drawing Date. Bonus Drawing winners will be eligible for all subsequent drawings and the final drawing on July 31, 2025. Odds of winning will depend on the number of eligible entries received, the date of the entry and the number of previous winners.

For each drawing Date, the winner will receive a check for the cash prize of five hundred dollars (\$500), subject to verification of eligibility and compliance with these Official Rules. The total approximate retail value of all Drawing Dates: \$7,000.

GRAND PRIZE DRAWING: After the conclusion of the Raffle Period, the winning Raffle Ticket number (the "Winning Number") will be selected at random from among all eligible Raffle Tickets purchased during the applicable Raffle Period. All drawings shall be conducted by and under the supervision of the LADD, whose decision is final and binding.

The Participant that purchased the Raffle Ticket with the corresponding winning Cash Prize will, subject to verification of eligibility and compliance with these Official Rules, receive fifty percent (50%) of the net proceeds (total collected by LADD minus any philanthropic donations made by participants and any related expenses from the Raffle Ticket sales) for the Raffle Period or any other pre-determined

guaranteed, minimum payout announced by LADD for the Raffle (the "Cash Prize"). All remaining net proceeds from the raffle, along with any philanthropic donations made by purchasers, shall be retained by LADD. There will one (1) Grand Prize winner.

No other Prizes will be awarded.

All Cash Prizes will be delivered via check within sixty (60) calendar days of the Cash Prize Claimant delivering the winning Raffle Ticket, executed Affidavit, and all other required documents to LADD.

ODDS: Odds of winning are based on the total number of Raffle Tickets purchased during the applicable Raffle Period.

TRANSFER OF RAFFLE TICKET: Raffle Tickets may not be resold to any other party. Any Raffle Ticket which has been deemed to have been resold shall be void. All individuals who re-sell, purchase, or receive a Raffle Ticket in violation of these Official Rules shall be ineligible to participate in the Raffle or to win a Prize, and may be deemed ineligible to participate in future raffles.

NOTIFICATION: Winner(s) will be notified by available phone number or mail/email address, as determined solely by Sponsor. To pay out any prize, Sponsor may require winner(s) to complete, sign and return Affidavit of Eligibility/Liability Release/Publicity Release forms and other applicable documents, which may require a social security number and form(s) of official identification, postmarked within ten (10) days of the date of notification. If a potential winner cannot be contacted, fails to timely claim the prize, is disqualified, fails to timely execute and return any required forms or information or if the prize notification is returned as undeliverable, an alternate winner will be selected from other potential winners and/or by random draw for all remaining eligible entries. If my reason or printing or other error, more prizes are claimed than the number of prizes set forth in these Official Rules, a random drawing will be held to award the advertised number of prizes in the relevant category. Under no circumstances will more than the advertised number of prizes be awarded.

TAXES: Each Participant acknowledges that s/he has been informed that the Internal Revenue Service ("IRS") has taken the position that amounts paid for chances to participate in raffles, lotteries, or similar programs are not philanthropic donations and, therefore, the price of a Raffle Ticket does not qualify as a deductible charitable contribution. The Prize winner is responsible for any and all federal, state and local taxes, fees and other government assessments on the awarded Prize. Furthermore, each Prize winner acknowledges that federal law requires that a tax withholding on certain prize values must be collected from winners upon award or distribution. Federal and state withholding laws are subject to change without notice. The withholding laws in effect at the time each Prize is claimed will be followed.

PUBLICITY & MARKETING: Acceptance of any prize constitutes permission to the Sponsor to use winners' name, address, voice, statements, image and likeness for purpose of advertising and trade, in any medium, without further compensation or notice, unless prohibited by law. Submission of contact information in connection with this Raffle (whether or not required), including mailing address, phone number and email address during entry constitutes permission for Sponsor to add entrant to Sponsor's customer database and to contact entrant in the future for promotional and other reasons. Entrant may opt-out of receiving such communications by contacting the sponsor directly.

PARTICIPANT'S GRANT OF LICENSE: By participating in the Raffle or accepting a Prize, each Participant hereby irrevocably and perpetually grants to LADD, Inc., and its designees a worldwide license to use, publish, reproduce, create derivative works of, distribute and publicly display any images or likenesses taken or captured of the Participant in connection with any participation in the Raffle or receiving a Prize (collectively, the "**Images**"), in any form, media or content which now or hereafter exists, for advertising, promotional or any other commercial purposes as well as non-commercial purposes. Each Participant waives any compensation for any use of such Images. Each Participant hereby releases and waives any claims, demands, damages, losses, liabilities and causes of action arising from LADD's, or its designee's, uses of the Images, including, without limitation, any claims for defamation, libel, invasion of privacy, publicity, personality, or exploitation of the Participant's name or likeness.

NO LIABILITY & INDEMNIFICATION: Sponsor and Sponsor Affiliates are not responsible for and entrants release each from any failures of any kind (whether caused by computer, technical or human error) which may either limit the entrant's ability to submit an entry, claim a prize or otherwise participant in this Raffle, or Sponsor's ability to include all eligible entries, conduct random drawings, notify potential winners, or otherwise execute this Raffle in the manner intended. Entrants further release and agree to indemnify Sponsor and Sponsor Affiliates from any and all liability, claims or actions of any kind whatsoever arising from injuries, damages, or losses to persons or property which may be sustained in connection with this Raffle, including, but not limited to: (a) the receipt, ownership or use of any prize awarded; (b) any travel or prize-related activity; (c) any typographical or other error in these Official Rules or any other materials disseminated by Sponsor; and (d) any technical malfunction, failure, error, omission, interruption, deletion, defect, delay in operation or communications line failure, regardless of cause, with any equipment, systems, networks, lines, satellites, servers, computers, or providers used by an entrant or Sponsor.

OTHER TERMS: Decisions of Sponsor on all matters related to the Raffle are final. Sponsor reserves the right to cancel or modify the Raffle for any reason, including but not limited to, if fraud, misconduct or technical failures destroy the integrity of the Raffle, or if a computer virus, bug or other technical problem corrupts the administration, security or proper administration of the Raffle as determined by Sponsor, in its sole discretion. Sponsor reserves the right to disqualify or prohibit the participation of an individual if fraud or tampering is suspected, or if the individual fails to comply with any requirement of participation or with any provision of these Official Rules.

CAUTION: ANY ATTEMPT TO DELIBERATELY DAMAGE OR UNDERMINE THE OPERATION OF THIS RAFFLE IS VIOLATION OF CRIMINAL & CIVIL LAWS. SPONSOR RESERVES THE RIGHT TO DISQUALIFY AND/OR SEEK DAMAGES FROM ANY INDIVIDUAL MAKING SUCH ATTEMPTS TO THE FULL EXTENT PERMITTED BY LAW.

DISPUTES AND GOVERNING LAW: The Raffle and the Official Rules shall be governed in all respects by the laws of the United States of America and by the laws of the State of Ohio without giving effect to any choice of law or conflict of law rule of any jurisdiction. ANY CONTROVERSY OR CLAIM ARISING OUT OF OR RELATING TO THE RAFFLE OR THE OFFICIAL RULES SHALL BE SETTLED BY BINDING ARBITRATION ADMINISTERED BY THE AMERICAN ARBITRATION ASSOCIATION ("AAA") IN ACCORDANCE WITH ITS COMMERCIAL ARBITRATION RULES, AND JUDGMENT ON THE AWARD RENDERED BY THE ARBITRATOR(S) MAY BE ENTERED IN ANY COURT HAVING JURISDICTION THEREOF. ANY ARBITRATION SHALL TAKE PLACE IN THE CITY OF CINCINNATI, OH. THE PARTIES AGREE THAT ANY CONTROVERSY OR CLAIM SHALL BE HEARD AND RULED UPON BY ONE (1) ARBITRATOR WHO SHALL BE SELECTED BY LADD. **PARTICIPANTS EXPRESSLY WAIVE ALL RIGHTS TO COURT AND JURY TRIAL.** Each Participant agrees that: (i) any and all disputes, claims, and causes of action not waived arising out of or in connection with the Raffle, or any Prize(s) awarded, shall be resolved individually, without resorting to any form of class action; (ii) any and all claims, judgments, and awards shall be limited to actual out-of-pocket costs incurred, including costs associated with entering the Raffle, but in no event attorneys' fees; and (iii) under no circumstances will Participant be permitted to obtain awards for, and Participant hereby waives all rights to claim punitive, incidental, consequential damages and any other damages (other than for actual out-of-pocket expenses) and further waives any and all rights to have damages multiplied or otherwise increased.

DISQUALIFICATION; CHANGES: LADD reserves the right at its sole discretion to disqualify any individual that tampers or attempts to tamper with the operation of the Raffle, re-sells a Raffle Ticket, violates the Official Rules, or acts in an unsportsmanlike or disruptive manner, or with intent to annoy, abuse, threaten or harass any other person. LADD reserves the right to, at its sole discretion, cancel, suspend and/or modify the Raffle, Event, Raffle Period or these Official Rules or disqualify any individual or Raffle Ticket for purposes of protecting the integrity of the Raffle or addressing changes in business operations or other circumstances, to the extent allowed under applicable law. CAUTION: ANY ATTEMPT TO DELIBERATELY DAMAGE ANY WEBSITE ASSOCIATED WITH THE RAFFLE OR UNDERMINE THE LEGITIMATE OPERATION OF THE RAFFLE IS A VIOLATION OF THESE OFFICIAL RULES AND OF CRIMINAL AND CIVIL LAWS AND SHOULD SUCH AN ATTEMPT BE MADE, LADD, INC. RESERVES THE RIGHT TO SEEK DAMAGES FROM ANY INDIVIDUAL RESPONSIBLE FOR THE ATTEMPT TO THE FULLEST EXTENT PERMITTED BY LAW.
